

COMMERCIAL PHOTO SHOOTS TERMS AND CONDITIONS

Membership

Corporate Membership is required to become eligible to rent Wave Hill for photo shoots. The following levels allow the specified rental access for one year:

- a. \$2,500 gains access to still photo shoot rentals.
- b. \$5,000 gains access to small film/video shoot rentals.
- c. \$10,000 gains access to large film/movie shoot rentals.

Rental Fees

After yearly Corporate Membership commitments have been fulfilled, the following daily rental fees apply:

| a. Still Photography Shoots with up to 15 people, minimal props, and no more than two passenger vans or cars | \$500 |
| b. Still Photography Shoots with more than 15 people | \$2,500 |
| c. Small Film/Video Shoots with up to five people and one vehicle | \$500 |
| d. Large Film/Movie Shoots with more than five people | \$10,000 |

Hours

Shoot days begin at 9am and end at 5pm. Wave Hill management must approve additional hours in advance, and overtime fees may apply.

Grounds

Shooting on the grounds is limited to open lawns, paved areas and interior areas that have been approved by Wave Hill. Equipment or personnel may not be placed within a planted garden bed, on bare soil or on top of a structure. The greenhouses are not available.

Buildings

Use of rooms within buildings at Wave Hill must be arranged in advance. Any decorating, rearranging, masking or use of electrical outlets must be approved by Wave Hill management prior to the shoot. Gallery areas are not available during exhibitions.

Vehicles

Placement and parking of shoot vehicles must be approved by Wave Hill.

Props

Some large or complex props may require an additional fee.

Rules

Wave Hill remains open to the public during photo shoots. Shoots cannot interfere with public access to gardens, galleries, parking spaces or buildings and must respect the personal space of our visitors. All public rules must be observed regarding picnicking, sports, radios, tree climbing, etc.

Insurance

At least 48 hours prior to your shoot, you must provide Wave Hill with a certificate of insurance in the amount of \$1,000,000 general liability, and naming Wave Hill as additionally co-insured for your shoot date(s).

Script

Wave Hill reserves the right to review all scripts and layouts to determine whether proposed sites and activities pose any threat to access, safety or to our plant collections and facilities.

Meals

Complete onsite catering is available through our exclusive caterer Great Performances. The Wave Hill Café is also available during public hours, Tuesday through Friday, 10am to 4:30pm.
